Dr. DiNinno and the board wished Dr. McClure a happy birthday and congratulated Mr. Nehlsen on the birth of his new baby.

Mr. Rizzo provide the board with an update on School Safety Measures that have been put in place over the past 5 year period including physical changes, training, procedural and community collaboration with local law enforcement.

Dr. DiNinno provided the board with an update on current and projected student enrollment as well as current and projected class size needs. Additionally, a list of top priorities, as determined by building principals was provided. Dr. DiNinno asked board members to hold on to this information and refer to it as the 2018-2019 budget is being built.

Dr. DiNinno explained that the District will begin to review the current strategic plan for reflection, assessment of goal accomplishment, and consideration of any additions or revisions. She indicated that a survey will be forthcoming followed by sign-ups for volunteers to be included as members of a Strategic Planning Committee. Additionally work groups would be utilized to dig into various components of the plan. The Education Committee is currently reviewing the survey.
