Mr. Jaynes provided the board with an update on the status of the construction project. He indicated that the district could consider selling the old lighting fixtures in the auditorium and that some payments were being held for a few projects until the projects fully meet the satisfaction of the district. Mr. Jaynes indicated that training was conducted to assist employees with using the new stage lighting, he is still monitoring the status of where to place a sign at the JHSH and tests are being conducted on the AC Unit to determine source and remedy for sound impact in classrooms.
