- CALL TO ORDER** Mrs. Jeanine Hurt-Robinson, Vice President, called the Reorganization Meeting of the Riverview Board of School Directors to order at 7:00 p.m., December 6, 2021, remote access via zoom as a result of necessity due to coronavirus pandemic sanctions.

- ELECTION OF TEMPORARY PRESIDENT** The floor was opened for nominations for the Election of the Temporary President (from Holdover Members) by Mr. Muscante, Solicitor. Mrs. Schaaf nominated Dr. McClure. Hearing no other nominations, nominations were closed. Dr. McClure was elected Temporary President with three (3) affirmative votes and one abstention (Dr. McClure) on roll call vote from the Holdover Members. The Reorganization Meeting was turned over to Dr. McClure.

Dr. McClure seconded the motion. Mrs. Schaaf was unanimously elected Vice President.
