

## Study Session-MINUTES May 11, 2015 – 7:00 p.m. – Central Office Conference Room

Tammy Good, Business Manager provided the board with a revised Proposed Final Budget as of May 15, 2015. She reviewed the changes since the proposed budget including:

- At this point, in time there will be no tax increase and millage rate will be set at 22.4462
- Still waiting for state property tax allocation
- Slight increase in Title I funds from last year
- Slight decrease from budget estimate for Title II funds
- \$4,500 increase to library for pop-up consideration requested by local library
- \$7,000 increase for junior high softball program
- \$17,530 increase for Food Service CEP program
- \$100,000 reduction for fund balance spending
- \$6,000 reduced for building improvements
- Decrease of approximately \$132,171 in estimated debt payments
- Increase of approximately \$17,000 for food service transfer for investments

Ms. Good explained that, at this point in time, this would result in an approximate \$183,033 budgetary reserve. The 2014 year end fund balance of approximately \$2,124,369 with a reduction of approximately \$500,000 for construction needs would result in a fund balance of approximately \$1,624,369. She also explained the potential surplus anticipated in 2015 would result in approximately \$1,874,369 fund balance monies.

The board continued in a discussion pertaining to the potential use of attrition with regard to the art teacher position that is currently open as a result of retirement. A decision was not finalized. It was agreed that this decision would be further reflected on and made within the next few weeks.

Ms. Good and Dr. DiNinno explained that a meeting is scheduled for this week to begin scheduling and planning for summer custodial work and the construction project.

Ms. Good provided the board with an update on the bond items and the status of the roof bids and construction project. She explained that debt service payments for 2015-2016 and beyond will be reduced by approximately \$40,000 and the life of the debt will extend by two years. Discussion pertaining to the cost of the dimmer board in the auditorium and District costs associated with the Pop-Up library placement at Verner was also conducted.

Mr. Hackworth reviewed appeals efforts with the board.

Ms. Good presented information pertaining to:

- a Fruit and Vegetable grant that is being planned at Verner for the 2016-2017 school year
- the potential to take advantage of a free breakfast and lunch program at Verner

• and the ability to update/replace food service equipment in the District through a no interest loan through Metz

She explained that the free breakfast/lunch program and loan figures are currently included in the Proposed Final Budget.

Dr. DiNinno reviewed the following topics indicating that board approval is being sought for each topic at next week's Regular Voting meeting:
