### b. Jeff McKenzie - Gas and Evacuation Update

Thank you, Mr. McKenzie, and I want to publicly thank you, and our administrative team, who worked calmly, collaboratively, and systematically to evacuate 500 students and staff and keep everyone informed, accounted for, and safe and secure. Great job, everyone. We met last week with our student life delegate and we will now hear from our administrators for their student life updates. Mr. Hewitt and Dr. Turk, let's start with you this evening. Dr. Monroe was out today, so we will ask Mr. Z to provide the 10th Street and Verner reports this evening.

### c. Principals - Student Life Updates

Thank you, everyone. Student life reports always remind us of why we work so hard to support the students in our school district. There are so many wonderful things happening in the district, and so many accolades that are students have achieved, and will achieve. Thank you, administrators. Finally, I wanted to have a discussion with the board regarding the snow day that occurred on January 19th. As you may or may not know, there was a recent legislative change in Pennsylvania related to flexible instructional time. Act 56 of 2023 **changes the requirement** that public schools be kept open for at least 180 days <u>and</u> 900 hours at the elementary level or 990 hours at the secondary level each school year, **to allow schools to be open 180 days <u>or</u> 900/990 hours in a school year**. The act took effect December 14, 2023. At Riverview, we have more than enough hours built in the calendar that this state legislative change **provides potential flexibility for whether or how a day must be made up**. Therefore, the recommendation both for this year, and in future calendars, that the "traditional" snow day not be made up by students or staff, and the Thursday before the Easter break remain intact and a holiday.

Dr. English moved into the next area of discussion: agreements, contracts and resolutions. There is only one item for next week in this section, and that is the AIU Program of Services Budget Proposal. As you may or may not know, the AIU's program of services budget is mandated by school code and is developed following a series of discussions among the district superintendents and administrators at the AIU. All Allegheny County Schools partner with the AIU to provide services in areas such as curriculum development and instructional improvement, educational planning, educational technology, continuing professional education, pupil personnel, state and federal liaisons and leadership support services. As is usually the case, the program of services budget reflects a very slight increase in the overall district allocation. Next week, The administration will recommend that the Board approve the proposed 2024/2025 Allegheny Intermediate Unit Program of Services Budget in the amount of \$2,263,093. The Allegheny County (AIU3) school districts' total contribution to the budget is \$1,936,965. The Riverview School District's contribution to the Program of Services Budget is estimated to be \$20,545.78. This is an approximate 340 dollar increase from last year, so fairly negligible increase. The districts' final withholding allocation will be based on the District Aid Ratio and Weighted Average Daily Membership (WADM). The withholding allocations will be determined by the Pennsylvania Department of Education sometime after July 1, 2024.
