Presentation from Draw Collective, as stated on Study Session.

Thank you for coming Dan and Alena. Dan passed out master plan spreadsheet, different because trying to collect numbers by year, etc.

Items are for all 3 schools, 24/25 school year, intended to focus on the kitchen in high school project, and a couple of other items to review and a line item for the 25/26 year, so as to separate kitchen costs. Things can move on and off list as needed.

JRSR HS: yellow items are pertaining to HS kitchen reno, numbers are estimates (engineers have note yet gone into space - not until Friday) placeholders and usually use higher numbers. Underground scanning proposal because no drawing of existing building, may have issues to contend with when digging. Kitchen - scanning item, equipment, ceilings/walls, HVAC, (bond out and budgeted and built a balance so that we could stay current) **Capital improvement project funding will be out by end of this year. (to right of red line is not in the budget ..... yet)** 

Verner: not much at Verner, roof upgrades. Need to add a quardrail.

10th street: installed, balancing unit now, structure reinforced, and waiting on final inspections to pass checklists.

Brian Hawk question to Dr. English - how much food for district is prepared at HS = 80% is prepared. It is the Hub.

Mrs. Chaparro asked, How much do we actually cook? Seems with the national lunch program that a lot is processed and pre prepared. How much high end equipment do you need?

We are bringing it up to standard.

10th street - refinish auditorium ceiling. This is a repair due to the roof install. Dan stated that these are the items highly recommended to do.

Next columns are what are wanted but would need to be added to budget.

Some items not through architects:

- safety decals (so building can look out but people not look in) branding/logos on these items.
- interior project at each school, flash up a bland space i.e. Verner library, high school athletic entrance, 10th street logos in gym, etc.
- upgrade to some equipment in our fitness areas.

Sound systems - in gyms and mobile. pricing for those as well. (hope to do this year)

Big item for the future - item 48, potential auditorium/gym addition at the high school. 86 feet from the gym to the street towards bakery, room to add there. It would be a simple box structure (75 by 105)

Discussion regarding where the best needs are for the schools for the future. Match facilities to the programs and what else can be done if they are matched.
