A Discussion was held with the board regarding the status of the 2020-2021 Budget. Dr. DiNinno and Ms. Good answered several budget questions and provided clarification on several budget items to the board. A \$411,000+ gap still exists between anticipated revenues and anticipated expenditures. Ms. Good shared several potential strategies for closing the gap. Dr. DiNinno indicated that the budget was created to include all current staffing, current programming, and much needed new math resources. She reminded the board that decisions made today also impact future budgets. Discussion on ways to close the gap will continue.
