Student Life Committee:

• The Student Life Committee shared and discussed the following topics:

- Continued collaboration with ABC Create for STEAM education opportunities. Gratitude was given to the Riverview Educational Foundation for their willingness to support this project and to the potential support of the PTO.
- Each school's volunteer activities to support those in need following the recent hurricane including Coin Wars, Classroom adoptions and donations to the Red Cross.
- Excitement over the collaborative project with Art Sparks to obtain a resident artist and for our students to create a mosaic that will be placed at the Oakmont stop of the PA Turnpike.
- Special field trip for members of the Jazz Band.
- Adjustments to Grace Notes and Chorus schedules.
- Wellness Update of activities being conducted at each building and with employees.
- Update on bridge sculpture indicating that funding is needed to obtain steel.
- Updates were provided on activities including athletics and homecoming plans as well as the VNN website.
- Elementary principals shared happening in their buildings including the science club, wellness activities, safety patrol, teacher mentors and SWIPBS.

The following committees provided reports and updates as follows:

- Finance Committee Architect and ESCP update was provided.
- Forbes and Legislation Dr. Loeffler indicated they still negotiating teacher contract at Forbes and the state budget not yet passed
- Eastern Area Schools Ms. Tompa shared that a meeting was held in August. Dr. Monroe indicated that Riverview has 5 students attending.

- Nathan Hart to conference and congratulations on the designation as a Music and Dance Teacher

Agreements:

Discussion pertaining to the approval of an agreement between the Oakmont Country Club and RSD to allow Cross Country team to use the facilities for meets at no charge. Since the documents was already reviewed by the solicitor, in order to enable the team to use the facility for their first meet, the board agreed to vote on the approval of this agreement at the meeting.

In order to meet timeline requirements for the ABC Create program the board agreed to vote on the approval of continuation with the program at the meeting.

Additional motions for potential approval shared by Dr. DiNinno included approval of auditorium manager agreement, AIU Community School East and a special education placement at PACE.
